About the Fund

Medallion Australian Equities Growth Fund seeks to provide investors with exposure to a high-quality portfolio of Australian companies listed on the ASX.

The Fund is style and sector agnostic but nevertheless carefully considers diversification by limiting portfolio weightings to a maximum of 10%. The fund looks to identify economic themes and fundamental changes in the business landscape which help to focus the Fund's attention towards the market sectors that offer the brightest outlook. By overlaying an extensive fundamental bottom-up research process, the Fund aims to identify high quality businesses exposed to structural growth opportunities early in a company's growth cycle.

It is the Managers belief that quality businesses in growing sectors have a higher probability of delivering positive revenue, cash flow, earnings, and dividend income revisions over the long term.

Although the Fund will have a bias toward high quality cash generative businesses with sound balance sheets and high-quality management teams, the Manager may adjust the Portfolio's strategy allocations depending on prevailing market conditions or other factors it considers relevant at the time in order to achieve the Fund's investment objective of outperforming the S&P/ASX 200 index across a full investment cycle.

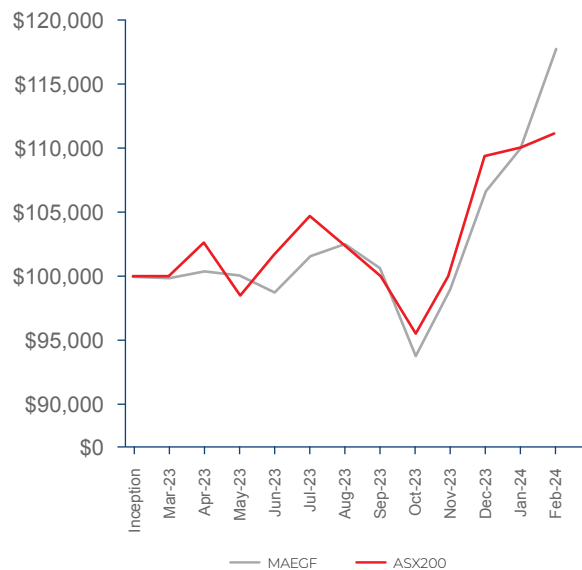
